This certificate was first issued on 31 October 2019 and remains valid as long as the requirements given in the National Technical Approval referred to hereinabove or the manufacturing conditions in the factory or the way of the product control by the importer itself are not modified significantly, unless suspended or withdrawn by the Authorized Body.
