1. Unscrew the Empty Dose of the NBS (hold the valve opening away from

the body)

2. Screw the PUR cleaner onto the NBS gun

3. Press the trigger and fill the pistol with a cleaner

4. Leave the cleaner in the gun for about 10–12 minutes (max. 15)

5. Press the trigger repeatedly and fill the pistol with a cleaner

6. Unscrew the NBS cleaner and remove it from the NBS gun

7. Wipe the excess cleaner from the adapter with a cloth, apply the silicone

adapter to the adapter

spray protective film layer

8. Screw the new NBS foam pistol onto the adapter

9. Press the trigger and let the foam fill the inside of the gun and remove the

remaining cleaner

10. The gun is ready for storage or reuse

**Warning** The can is under constant pressure, do not spray against open fire or glowing

objects. Apply to PU foam residues from a distance of about 25-35 cm.
